BREASTFEEDING PRACTICES AMONG NURSING MOTHERS WITH UNDER-FIVE CHILDREN IN ILESA, OSUN STATE, NIGERIA

ABSTRACT

Introduction: One of the oldest practices known to mankind is breastfeeding and breast milk had been recognized as the appropriate food for babies over the ages. However it is not clear if nursing mothers of under-fives are fully informed about its benefit thus the reason for this study which assessed the knowledge, attitude and practices of nursing mothers towards breastfeeding in Ilesa, Osun state, Nigeria.

Methods: It was a descriptive cross-sectional study and the respondents were 375 nursing mothers with children below five years of age attending postnatal clinics. They were randomly selected from two local government areas and an interviewer administered, semi-structured questionnaire was used to obtain information on maternal socio-demographic characteristics, knowledge, attitude and practices of the nursing mothers. Simple descriptive statistics were performed using SPSS version 20.

Results: A total of 350 (93.3%) respondents completed the study; 90% had antenatal care (ANC) and 74% carried out exclusive breastfeeding (EBF) for 6 months. Among the respondents, 59% initiated breastfeeding on the day of delivery and 79% agreed breastfeeding was good for babies. Sixty five percent of the respondents did not experience

difficulty in initiating breastfeeding. For 43.1% of the respondents, the most usual weaning food was pap and 88% of the respondent used boiled water in preparing supplementary food.

Conclusion: The respondents demonstrated good knowledge and positive attitude towards exclusive breastfeeding and understood its benefits. Pregnant women should be counseled on the need for ANC and appropriate education on breastfeeding practices should be provided at the clinics.

INTRODUCTION

Breastfeeding is one of the most effective ways to ensure child health and survival. The best infant feeding plan for optimal growth, development and health as recommended by the World Health Organization (WHO) and United Nations Children's Fund (UNICEF) is starting breastfeeding in the 1st hour of delivery, exclusive breastfeeding (EBF) for the first 6 months of life and continued breastfeeding together with suitable complementary foods for up to 2 years or beyond.² Breastfeeding has an important role in many countries for public health and studies.³ epidemiological About three

quarters (74%) of black infants are ever breastfed, and this is below the national average of 83%.⁴ About half of the 80% of neonates given breast milk worldwide initiated breastfeeding in the first hour of birth, and in developing countries late initiation of breastfeeding is still a challenge.⁵

In many countries, EBF is reportedly low and there is a declining rate of continued breastfeeding among poor mothers. ⁵⁻⁸ Despite WHO recommendations on breastfeeding, globally the picture falls short of these standards, as only 44% of infants aged 0-6 months worldwide were exclusively breastfed over the period of 2015-2020. ⁹ In Nigeria, the prevalence of EBF nationwide is 17% with regional variations. ¹⁰ Studies have shown an inverse relationship between EBF and infant mortality rates in developing countries. ^{11,12} Optimal breastfeeding is so critical that it could save the lives of over 820,000 children under the age of 5 years each year. ⁹

There is a decrease in child death with a long - term health benefits in children who are optimally breastfed.² It could also reduce hospitalization among children with otitis media, respiratory infection and diarrhea.⁵ Longer duration of breastfeeding also contributes to the health and well-being of mothers and reduces the risk of ovarian and breast cancers.⁹ The aim of this study was to determine the breastfeeding knowledge, attitude and practices among mothers of under-fives in Ilesha, Osun State, Nigeria; to help know their current breastfeeding practices and provide a basis for improving these practices.

METHODS

Study setting




Figure 1: Study Area

The study was carried out in Ilesa town, Osun State (Figure 1). Ilesa is an ancient city in Yoruba land in South Western Nigeria. It is also the name of a historic semi-urban settlement and the largest town in Ijesa land located between latitude 7.6291 °N and longitude 4.7372 °E in rainforest belt. It has a population of 228,297 according to the 2009

population census. Ilesa is a large nucleated settlement, initially a caravan trading center, but now a commercial, agricultural and processing city. The 2 major hospitals in Ilesa are: Federal-government owned Wesley Guild Hospital (which is one of the units of Obafemi Awolowo University Teaching Hospitals Complex) and the Osun State owned General Hospital. There are 16 privately owned health centres or clinics and 20 publicly owned Primary Health Care Centres (PHCs) with 4 dispensaries scattered in different locations in Ilesa. The public and private health centers in Ilesa provide a wide variety of health services.

Research Design

A descriptive cross-sectional facility-based study.

Sampling Technique

The study location is Ilesa town with Ilesa East and Ilesa West Local Government Areas (LGAs) made up of 21 wards. Ilesa East has 11 administrative wards while Ilesa West LGA has 10 administrative wards. In Ilesa East LGA there are one Comprehensive Health Centre and 12 PHCs while Ilesa West LGA has one Comprehensive Health Centre and 8 PHCs. Twelve of the health care centers were randomly chosen from the 20 available publicly (state government) owned PHCs, 6 from Ilesa east and 6 from Ilesa west LGA. Convenience sampling technique was used to recruit nursing mothers who were attending postnatal clinics at the selected health care centers.

Sample inclusion/exclusion

Mothers between ages 15-49 years who had breastfed their under-fives or are still

breastfeeding and are residents of the study area were recruited. Mothers whose children were seriously ill were excluded from the study.

Sample size

The minimum sample size was calculated using the Leslie Fischer's formula cited by Araove:¹³

Minimum sample size was 341

Adding 10% attrition, the total number of respondents to be recruited was 375.

Data Collection Tools and Methods

Data was collected using a pretested interviewer-administered questionnaire. The questions were in three sections as follows; demographic characteristics, breastfeeding knowledge, attitude and practice among nursing mothers.

Data analysis

Data was analysed using the IBM/Statistical Product and Service Solution (SPSS) version 20. Summary statistics using mean and standard deviation for continuous variables such as age and number of children were performed. Frequencies and proportions for categorical variables were generated for socio-demographic characteristics of the respondents, breastfeeding knowledge, attitude and practice.

RESULTS

Socio-Demographic Characteristics of Respondents

A total of 375 questionnaires were administered, 350 had complete data and were analyzed giving a response rate of 93.3%.

Table I shows the socio-demographic characteristics of the respondents. The age of the respondents ranged from 20 years to 49 years with a mean age \pm SD of 33 \pm 6 years. Fifty-three percent of the respondents were within age group 30 – 39 years and 72% were Christians. Sixty-eight percent had tertiary level of education and 88% were of Yoruba ethnicity. Eighty-one percent were from monogamous family while 51% were respondents with two children.

Breastfeeding Knowledge

To assess breastfeeding knowledge, tables 2 and 3 answered some component questions. Ninety percent of the respondents had antenatal care, 74% exclusively breastfed their child and 73% believed exclusive breastfeeding was beneficial to their child (Table II).

Fifty-nine percent of the respondents felt babies should be breastfed on the day of delivery while 83% believed exclusive breastfeeding should last for the first six months of life. Fifty-nine percent of the respondents felt breastfeeding must be stopped when diagnosed with HIV/AIDS (Table III)

Breastfeeding Attitude

Seventy nine percent of the respondents agreed that breastfeeding helps mother and baby bond specially, 79% disagreed it was not good for babies while 70% of the respondents agreed sexual pleasure should not be the only purpose of the woman's breast (Table IV).

Breastfeeding Practice

Sixty five percent of the respondents did not experience difficulty in initiation of breastfeeding. In 43.1% of the respondents, the most usual weaning food was pap. Among

the respondents, 80.0% used cup and spoon as mode of administration of breast milk

substitute, 87.4% washed their utensils immediately before and after use and 88% used boiled water in preparation of supplementary food (Table V).

DISCUSSION

The results from this study indicated that the women's awareness of exclusive breastfeeding (EBF) was good as 67% of the respondents had heard of EBF. Similarly, reports from Lagos and Osun States in Nigeria showed a high awareness of 86.3% and 88.0% respectively. 14,15

Also, from Southwestern Ethiopia, a high awareness of 93.6% was observed. However contrary to the above findings, some reports from Zimbabwe and China found low awareness of 30% and 20% respectively. The difference in the findings of these studies can largely be explained by the differences in the samples of the studies with the possibility of targeted health education from health workers.

Although some reports have highlighted global decline in breastfeeding rates, the results of this study indicated more than half of the respondents (74%) had exclusively breastfed their children. This finding is higher than a reported rate of 60% of EBF in a study undertaken in Kerala, India and also much higher than a rate of 40% of EBF found among respondents in a study done in Fiji, South Pacific Ocean. In contrast, a higher rate of 98% of EBF was reported in Zahedan, Iran. The difference in the findings of this study compared to others may be attributed to socio-demographic and cultural differences.

Informal social support systems have been considered more important in predicting breastfeeding intentions amongst low-income nursing mothers. By the results of this study however, demographics in the low income set still had formal breastfeeding education and exclusively breastfed their babies as a result of the knowledge acquired through formal education. This may be due to the fact that formal health care services are considered sacrosanct authority in this clime and nursing mothers are eager to adhere to their instructions regardless of the type of informal social structure they may belong. Prior results have linked increased breast feeding duration

with improved fine motor skills, general motor skills and quicker language development. This may be supported by findings of the present study as a good percentage of mothers reported that exclusive breastfeeding was beneficial to their child. Similarly, Adithi and Vinodh reported that majority of their respondents observed that breast milk is protective for the baby and strengthens the immune system. ²⁶

A high proportion of mothers in this study, 79% believed that breastfeeding helps mother and baby to bond specially. Similarly, a finding of 71% was observed by a study done in India and 78.6% in a study done in Egypt. ^{27,28} However, in a study done in North India, a higher proportion of 98.3% believed that breastfeeding boosts mother and child bonding. ²⁹ The differing proportions may be attributed to the cultural differences.

Among the study respondents, 64.9% did not difficulty experience in initiation breastfeeding while 35.1% experienced difficulty in breastfeeding initiation. However, in a study done in Italy, around 70.3% of mothers experienced difficulties in initiation of breastfeeding.³⁰ The difference in the studies is likely to be due to the breastfeeding education given to the mothers in this study. The impact of the acquired knowledge was also evident in the fact that majority of the nursing mothers washed their feeding utensils before and after use and used boiled water in preparations of feeds. An examination of the breastfeeding education content in the study showed that the information was accrued on the health promoting benefits of breastfeeding and the good it does their babies. It follows therefore that nursing mothers, having had such information will have more favorable disposition to breastfeeding.

CONCLUSION

This study has shown that breastfeeding knowledge amongst nursing mothers was good and there was favorable attitude towards breastfeeding which was apparent in their breastfeeding practices. All pregnant women should be encouraged on the need for antenatal care and appropriate education on breastfeeding practices should be provided at the clinics.
