# ANTHROPOMETRIC PARAMETERS AND THE PATTERN OF MORBIDITIES AMONG ELDERLY PATIENTS IN THE GENERAL OUT-PATIENT CLINIC, UNIVERSITY OF ILORIN TEACHING HOSPITAL, ILORIN, KWARA STATE, NIGERIA.

#### **ABSTRACT**

Introduction: Most elderly people suffer from various chronic medical diseases whose can be evaluated by anthropometric parameters, but these parameters are not sufficiently used by healthcare givers during clinical evaluation. This study is aimed at determining the anthropometric parameters and the pattern of morbidities among elderly patients in the General Out-Patient Clinic in the University of Ilorin Teaching Hospital (UITH), Ilorin, Kwara State, Nigeria.

Methods: This was a cross-sectional descriptive study carried out among 307 elderly participants. They were assessed using an interviewer-administered questionnaire and the anthropometric parameters (BMI, MUAC, and Calf Circumference) measured following standard guidelines. The data analysis was done using Version 21 of the Statistical Products and Service Solutions (SPSS-21). Chi-square was used to test associations and p-value < 0.05 was considered statistically significant.

**Results:** About a quarter of the elderly (26.7%) were overweight while 12.4% were obese. Close to one third of the respondents (29.3%) had low calf circumference, while 3.9% among the respondents had low MUAC. The most prevalent disease among the respondents was hypertension (53.0%),

followed by diabetes (13.3%) and osteoarthritis (10.3%). Majority of the respondents (78.2%) were taking multiple medications while 39.1% of the respondents reported history of multi-morbidity. BMI showed a statistically significant relationship with hypertension, diabetes, osteoarthritis, and psychological problems, age, sex, MUAC and CC.

**Conclusion:** Anthropometric measurements are important tools to assess the clinical status of the elderlies during their routine visit for care.

#### **INTRODUCTION**

Anthropometric parameters such as Body Mass Index (BMI), Calf Circumference (CC), and Mid-Upper Arm Circumference (MUAC) have been shown to be of easy use in assessing chronic medical conditions among the elderly. Anthropometric parameters are good indicators to identify individuals who are at risk of developing non-communicable diseases. The parameters are simple, portable, non-invasive, cheap, and simple to

use in geriatric populations for early diagnosis and prompt medical interventions.<sup>4</sup> On account of the difficulty in measuring the height of the elderly due to some anatomical issues, MUAC and CC are more preferred to BMI, however they are not frequently used in the developing countries.<sup>5</sup>

Elderly people are prone to poor nutrition which increases the risk of infections, disease conditions and prolong hospital stay.<sup>6</sup> Most elderly patients are placed on multiple medications on account of these conditions and comorbidities.<sup>7</sup>

The data of anthropometric measures among the elderly especially in the out-patient clinic is scarce especially in low-income countries. A study done by Agarwal et al. showed that malnutrition increases the risk of mortality among the elderly. The negative effects of malnutrition adds more stress on health care facilities requiring more nursing care and prolong hospital stay which indirectly increase hospital costs. This study aimed to assess the anthropometric measurement (Mid-Upper Arm Circumference, Body Mass Index and Calf circumference) and the morbidity pattern among the elderly in the General Out-Patient Clinic in UITH, Ilorin.

#### **METHODS**

#### Study design and setting

This was a hospital-based descriptive cross sectional study conducted in the Geriatric clinic of the Family Medicine Department of University of Ilorin Teaching Hospital Ilorin (UITH), Ilorin. Kwara State has 16 local government areas (LGA) with Ilorin being the largest city. The people of the state are farmers, traders, self-employed, artisans, private employees and civil servants. The major religions are Islam and Christianity.

The Department of Family Medicine in UITH provides a comprehensive, coordinated, continuous and primary care to all patients irrespective of their age, gender or diseases. The study population comprised of elderly people aged 60 years and above. The data collection time was done within 3 months (between July and September) in 2017.

#### Inclusion and Exclusion Criteria

The inclusion criteria were all elderly (60 years and above) patients who had given written informed consent. The exclusion criteria were the elderly requiring hospital admission, those with emergencies necessitating immediate attention, patients too weak to stand erect and individuals with clinically demonstrable ascites and edema.

#### Sample Size Estimation

In order to determine the minimum sample size (n), the study by Adebusoye et al. which reported

61.9% as the prevalence of nutritional problems among elderly patients presenting at General

Outpatients Department (GOPD) Clinic of University College Hospital (UCH), Ibadan, Nigeria

was used.<sup>12</sup> For precision, the desired degree of accuracy (d) or margin of error allowed was

0.05. To ensure that the results obtained from the sample population had a 95% confidence level

(z) of representing the true population, a value of 1.96 was used. The statistical formula (Lesley

Kish's formula) for determining minimum sample size for health studies used by Fisher and his

colleagues was used.<sup>13</sup>

Therefore, minimal sample size used was 362. However, the study population was less than 10,000 (1,500) therefore, the sample size was adjusted using the formula,

In taking care of incomplete or missing data; 95% response rate was assumed. Hence the final sample size was adjusted to compensate for the response rate using the formula;

ns = 292/0.95 = 307

Thus, a sample size of 307 was used for this study.

#### Pretest

Thirty-one elderly patients (10% of the estimated sample size) were used to pretest the instruments at the General Outpatient Clinic of the Kwara State General Hospital Ilorin in order to determine the acceptability of the instruments, its logical sequence and the average time required to administer them. The research assistants were Junior Resident Doctors from the Department of Family Medicine. They were trained a month prior to the conduct of the research. Effort was made to ensure they were proficient in interviewing patients during the pilot study. administered the questionnaires to patients, and were supervised by researcher. Appropriate corrections were made to the instruments after pretesting.

#### Sampling Technique

Patients that met the inclusion criteria from the study population were recruited into this study using the systematic random sampling technique. Data collection time was 3 months from July through September 2017. Medical According to the Records Department of the hospital, an estimate of 500 elderly patients was seen monthly. Total number of elderly patients expected to be seen during this 3-month period was 1500 with an average of about 125 patients per week (5 working days) and 25 patients per day. The sampling interval (sampling frame/sample size) with a recruitment plan of 307 patients was 1500/307 which gave 4.89 which is approximately 5.

Every folder was assigned a number from 1 to 25. The first patient was chosen from the sampling frame by simple balloting from a box of sealed numbers, numbered 1 to 5, thereafter every 5th folder was chosen if the patient met the inclusion criteria. However, if the patient did not meet the inclusion criteria or had previously been recruited or patient refused further participation, the next qualified consenting elderly patient was recruited till the number required for that day was met.

#### Data Collection

Data was collected by the researcher and two trained research assistants. Respondents' folders were serialized with numbers written on them to avoid multiple administrations. Information from the interview, clinical measurements and laboratory results were recorded in the participants' questionnaires.

The instruments used were:

- a. Semi-structured questionnaires designed by the researchers
- b. Flexible non-elastic measuring tape
- c. Seca 274 free-standing Stadiometer

#### Anthropometric Parameters

- a. Calf Circumference (CC): The participant was seated with the left leg hanging loosely and the calf exposed. The Flexible non-elastic measuring tape was wrapped around the calf at the widest part and the measurement was noted. Additional measurements above and below the point were taken to ensure that the first measurement was the largest. It was recorded to the nearest 0.1cm. Each measurement was taken twice, and the average was calculated. Interpretation: Low when CC less than 31cm, Normal when CC was greater than 31cm.
- b. Mid-Upper Arm Circumference (MUAC): Each subject stood with weight distributed evenly on both feet and right arm bent to 90° at the elbow. The arm length of the upper arm was

measured from the lateral projection of the acromion process of the scapula to the inferior margin of the olecranon process of the ulna. The mid-way of the arm length was determined and marked. Circumference measurement was performed with a measurement flexible non-elastic measuring tape positioned perpendicular to the length of the arm, at the marked location. It was recorded to the nearest 0.1cm. Each measurement was taken twice, and the average was calculated. Interpretation: MUAC less than 21, score = 0; 21 - 22, score = 0.5; 22 or greater, score = 1.

c. Body Mass Index (BMI): BMI (kg/m²) was calculated by dividing the subject's weight in kilogram by the square of the subject's height in meters using a Seca 274 free Standing Stadiometer (made in the United Kingdom). Using the BMI, the subjects were grouped into categories. BMI of less than 18.5kg/m2 = underweight; 18.5 - 24.9kg/m2 = Normal weight; 25.0 - 29.9kg/m2 = Overweight; 30kg/m2 and above = Obesity.

#### Data Analysis

The collected data was analyzed using the Version 21 of the Statistical Products and Service Solutions (SPSS-21). Frequency distribution presented in tables was generated to reveal percentages and proportions of the various variables. Chi-square test was used to find the level of significance of association between categorical variables. The level of significance of this study was set at 5% (p<0.05).

#### **Ethical Considerations**

Ethical approval was received from the Ethical Review Committee of University of Ilorin Teaching Hospital (Reference number: UITH/CAT/189/19A/082). The study was introduced to prospective subjects (elderly patients) at presentation. Participants were adequately informed about the study and a written informed consent was obtained before being recruited into the study. The

participants were informed that participation was voluntary and that they could decide not to participate or even withdraw from the study at any time.

#### **RESULTS**

# Socio-demographic characteristics of the respondents

The highest number of respondents, 120 (39.1%) were in the 60 to 64 age group. Females were more in the study (76.50%) and most (43.0%) were unemployed. Among the respondents, 8.5% and 3.6% were ex-smokers and former alcoholic respectively (Table 1).

# Morbidity pattern and Drug Histories among respondents

The most prevalent disease condition among the respondents was hypertension (53.0%), followed by Diabetes Mellitus (18.5%), osteoarthritis (14.3%), psychomotor disorders

(11.7%) and body pains (4.2%). Over one-third of the elders (39.1%) had more than one chronic disease while majority (78.2%) were taking more than one medication (Table 2).

### Association between Age group, Sex and Diseases

The male to female ratio was 1:8 in the age group 60-64 years; however, there was a slight switch as the age advanced (M:F = 2.5:1) which was statistically significant (p=0.001). Osteoarthritis (p = 0.034), dental pain (0.001) and Benign Prostatic Hyperplasia (0.005) were statistically significant in the elderly (Table 3).

#### Gender differences in disease presentations

Some chronic diseases like hypertension (76.7%), diabetes (82.5%), osteoarthritis (90.9%) and musculoskeletal pain were prominent among females, while cataract (62.5%), Chronic Obstructive Pulmonary Disease (COPD) (100%), and dental pains (54.6%) were higher among males. Among the diseases, osteoarthritis, psychological problems, Chronic Obstructive Pulmonary Disease (COPD), cataract and dental pain were statistically significance (p<0.005) (Table 4).

# Anthropometric parameters of respondents

Slightly above a quarter (29.3%) had low Calf Circumference (CC) while a small number of the respondents 3.9% had low MUAC. About a quarter of the respondents (26.7%) were overweight while 12.4% of the participants were obese (Table 5).

# Relationship between Body Mass Index and other variables

The ages at risk of overweight and obesity are between 60 to 64 years and 70 to 74 years old respectively; meanwhile advanced age group was more malnourished. The elders with lower CC (37.8%) and MUAC (83.3%) showed more underweight or undernourished values. The association of BMI with age, sex, cigarette smoking, MUAC and CC were statistically significant (p values = 0.002, 0.012, 0.028, 0.001, 0.001 respectively). Most diseases in this study were related to overweight obesity. Hypertension, and osteoarthritis, diabetes and psychological disorders were more associated with high BMI with statistical significance (p-value = 0.011, 0.003, 0.002, 0.007 respectively).

#### **DISCUSSION**

In the current study, we examined the anthropometric parameters and the morbidity pattern of 307 elderly participants who visited the General out-patient Clinic in the Department of Family Medicine, UITH, Ilorin. Elderly women were more than their male counterparts and this could be due to a better health-seeking behavior among women which is similar to the findings from the

studies done by Suominen-Taipale et al., Cameron et al. and Adebusoye et al. 14,15,16 However, this is in contrast to the study of Sahoo et al. 17 With advancing age, male gender dominates significantly similar to the studies by Adebusoye et al., Lee et al., and Alharbi et al. 16,18,19

In this study, most of the diseases in the elderly are Non-Communicable Diseases (NCD) which is similar to the study done by Alharbi et al. and Udoh et al. 19,20 Hypertension was found to be the most common morbidity among the elderly in this study, followed by Diabetes, osteoarthritis and psychological problems. Meanwhile, over one-third of the elders (39.1%) had multiple morbidities; majority among elderly patients were on polypharmacy. This finding varies from region to region possibly due to the different study areas and tools used. 16,21-24

A large proportion of the elderly patients use more than one medication on account of multiple chronic diseases. The multiple morbidities presented by the elders could cause irrational prescription of drugs by healthcare givers which was found in the study by Kwan et al. <sup>25,26</sup>

The risk of obesity among the elderly and the high proportion of overweight in this study is worrisome especially between 65 and 74 years. This finding is close to the result seen in a study done by Amany et al. in Mansoura City and Fakhouri et al. in USA. <sup>27,28</sup> Females were found to be more obese than their male counterparts which is similar to the study done by Kim IH et al., Muhammad T et al. and Ashley J Cooper et al. <sup>29,30,31</sup> This could be as a result of the hormonal changes in females, which has made female gender prone to higher risk of developing obesity-related co-morbidities as reported by Kapour et al. <sup>32</sup>

Most diseases among the elderly in this study were related to high Body Mass Index (BMI) similar to the findings in other studies. <sup>33-35</sup> The findings from different related studies have shown that overweight and obesity are the main modifiable risk factors of Non-Communicable Diseases. <sup>36,37</sup> Undernourished

elderly in this study revealed an association with lower Calf Circumference (CC) and Mid Upper Arm Circumference (MUAC) which is similar to the reports from the study of Bonnefoy et al. and Cuervo et al. <sup>38,39</sup> The BMI was significantly associated with MUAC and CC, similar to some studies. <sup>40-41</sup> It has been found that MUAC and CC are easy to measure, correlates with BMI and they can be routinely used in the community or clinics in assessing the elderly. <sup>42</sup>

#### **CONCLUSION**

The risk of overweight and obesity among the elderly in relation to some Non-Communicable Diseases is alarming and requires urgent attention. Early assessments with simple anthropometric parameters like Body Mass Index, Calf Circumference and Mid Upper Arm Circumference are encouraged in the assessment of the elderly to improve their quality of care.
