## FACTORS ASSOCIATED WITH DIFFERENTIALS IN MODERN CONTRACEPTIVE USE AMONG CURRENTLY MARRIED WOMEN IN NIGERIA: MUSLIM NORTH VERSUS MUSLIM SOUTH

#### **ABSTRACT**

#### Introduction

Despite the federal government's modern contraceptive prevalence (mCPR) target of 27% by 2020, mCPR remained abysmally low. Recent data from the most recent Multiple Indicator Cluster Survey revealed mCPR of 18.3%, although with significant differentials along region and religious affiliations. This study examined factors associated with modern contraceptive use among currently married Muslim women in Northern and Southern regions of Nigeria

#### Methods

The study analysed secondary data pooled from the three most recent successive Nigeria Demographic and Health Survey data sets (2008, 2013, and 2018). Analysis was restricted to currently married Muslim women aged 20-40 years, who have given birth to at least a child and have at least two living children as at the time of the survey and were not currently pregnant. The weighted sample size for the study was 22,653 women: (2018=8,605; 2013=7,830 and 2008=6,217). The outcome variable was modern contraceptive use, defined as whether a woman is using any modern contraceptives coded as 1, or not, coded 0. Binary logistic regression was performed.

#### **Results**

Significant regional differentials in mCPR persist. At the multivariate level, education, wealth index, occupation, autonomy, joint decision on contraceptive use and knowledge of methods were significant predictors of mCPR among northern Muslim women. Among southern Muslim women, age, autonomy, joint decision on contraceptive use and knowledge of methods were factors that significantly predicted mCPR.

#### Conclusion

Within homogenous religion, regional differentials accounts for differences in modern contraceptive use in Nigeria, thereby providing useful information for programmes and policy.

#### INTRODUCTION

The population of Nigeria is almost evenly distributed according to religion, with Islam religion predominantly practiced in the North, while Christianity is predominantly practiced in the South. Contraceptive use among women in Nigeria follows regional, religious, and socio-economic differentials. The use of contraceptives has been particularly influenced by religious beliefs and practices. Substantial amount of literature have reported lower contraceptive

use among women affiliated to Islam religion relative to their Christian counterpart.<sup>2-5</sup> However, even among Islam religion, regional variation is an important factor in discourse regarding use of contraceptives.

For instance, in a systematic review of factors influencing sexual and reproductive health (SRH) of Muslim women, the authors found SRH knowledge among Muslim women to be poor.2 The women also exhibited negative attitude which influenced their access and use of SRH services. Factors that were associated with access and use of SRH services including contraceptives were: misconception knowledge, poor contraception, negative attitude towards contraceptives, religious and cultural views, fear of stigmatization and opposition from partner and family members among others.

Likewise, substantial number of studies have linked contraceptive use with women's socio-economic attributes including: autonomy, maternal level of education, place of residence, religion, work status and number of children among others. Some studies found factors including age, education, employment status, number of living children among others to predict modern contraceptive use among women. 5,10-15

Also, most of these studies reported that older age groups especially the late 20s and were associated with increased likelihood of modern contraceptive use, while others have reported education and employment status to be positively associated modern contraceptive with use. 5,10,11,14 Similarly, some authors while assessing factors associated with unmet fertility desire and perception about ideal family size among women from Bangladesh using evidence from Demographic and Health survey, found the fertility outcome of the women was higher than their desired level, while several socio-economic factors were found to influence unmet fertility desires including place of residence, religion, employment status, experience of child mortality, wealth index, maternal education and partner's education.<sup>16</sup>

More so, a study which assessed differentials in contraceptive use among women from the North and South. found substantial differentials modern contraceptive in prevalence according region.<sup>3</sup> to contraceptive prevalence rate was more than three times higher among women in the southern region relative to their Northern counterpart. The authors found sociodemographic factors, religion and exposure to family planning messages were significant predictors of contraceptive prevalence rate

Several studies on contraceptives especially in Nigeria have included religion as one of its explanatory variables. However, there seems to be scarcity of studies that have focused on a particular religion, while examining regional variation and creating a model for religion, putting into consideration regional variation. Also, a study contraceptive use according to religion and ethnicity among women of reproductive age found that current use of contraceptives was lower among women affiliated to Islam religion relative to their Christian counterpart. Even after controlling for other socio-demographic attributes, Muslim demonstrated women lower current contraceptive use.

However, there is scarcity of studies that have exclusively examined differentials in modern contraceptive use among Muslim women, putting into consideration regional differentials. This knowledge gap informed the conduct of this study. Hence, building a model with consideration to regional variation, this study examined modern contraceptive use among Muslim women in the Northern and Southern regions of Nigeria and the factors associated with differentials in modern contraceptive use between them.

#### **METHODS**

### Data Source, population, sampling and sample size

The study involved analysis of secondary data pooled from three successive Nigeria Demographic and Health Surveys (NDHS) Dataset (2008, 2013 and 2018). Specifically, the individual recoded dataset was analysed.

The NDHS is a nationally representative survey of women of reproductive age from 15-49 years who had given birth to at least a child five years preceding each survey and men aged 15-59 years. Detailed sampling technique used for the three surveys have been reported in the final report. Data for the study was collected using a questionnaire. The 2018 survey included a biomarker questionnaire. Information obtained using the questionnaire included birth history and child mortality, knowledge, use and source of family planning methods, antenatal, delivery and postnatal care among others. For this study, analysis was restricted to currently married women living with their partners, with at least two living children, not currently pregnant and in the age group 20-40 years. The choice of this age range is because of the assumption that contraceptive use among this age group should be relatively high when compared adolescent mothers and older women above 40 years who are most likely to be approaching menopause. The weighted sample size was 26,616 women.

#### Measurement of Variables

The outcome variable for this study is modern contraceptive use. The original variable used asked a question regarding the type of contraceptive a woman was currently using. Women who reported using a modern method were categorized as 1 while those who were not were categorized as 0. Explanatory variables used included: age, age at first birth, place of residence (rural or urban), region of residence, educational attainment, employment status (working or not working), household wealth (based on NDHS classification), antenatal attendance, place of delivery as well as autonomy: measured using four variables which asked questions on person who decides on respondents healthcare need, person who decides how respondents earnings are spent, person who usually decides on large household purchase and person who usually decides on visit to family. Media exposure was measured from a composite of three variables namely: frequency of listening to radio, television and reading newspaper. It was then dichotomised as either exposed to at least one media source, coded as 1, and not exposed to any media source, coded as 0. The explanatory variables used in this study were based on their significant association with the outcome variable at the bivariate analysis (p<0.001) and based on findings from previous study.<sup>17</sup>

#### Data Analysis

Data analysis involved performing multivariate univariate. bivariate and analyses. The univariate level involved frequency count and percentages. bivariate level involved the use of Chi-square test to check for association between variables. The multivariate level involved performing binary logistic regression. The use of binary regression was necessitated by the fact that the outcome variable was dichotomized, coded as 1 for use of modern contraceptive use and 0 for non-usage. The results were presented as adjusted odds ratio (AOR) and confidence intervals at 95% level of significance. Due to the complex nature of the DHS survey, the Stata "svy" command was applied at the bivariate and multivariate level.

#### **Ethics**

The protocol used for the survey was reviewed and approved by the National Health Research Ethics Committee of Nigeria (NHREC) and the ICF Institutional Review Board. All the questionnaires were finalized in English and translated into the three major languages of Hausa, Yoruba and Igbo.

#### **RESULTS**

#### **Socio-demographics**

Table 1 presents the distribution of study participants according to socio-demographic characteristics. Women in age group 20-30 years constituted nearly two thirds 62% of the total sample. Exactly half were in the low fertility regime (60%). Nearly three quarters (72.1%) of the study participants had their first birth as adolescents, followed by (27.3%) in the age group 20-29 years. Majority of the study participants, 69.4%,

had no formal education, while 13% had secondary education and 3% had tertiary education. More than half (58%) of the women were from the poor household and about three quarters (71%) resided in rural areas. Majority of the women were from the Northern region (88.8%), working (79.3%) and had between 1-4 children (64%).

Nearly two thirds (64%) had autonomy, while only (5%) jointly decides contraceptive use with their partner (Table 1).

#### Bivariate Result

The trend in modern contraceptive use among the women is presented in table 2. result revealed that modern contraceptive use among Muslim women in the North and Muslim women in the South was (3.5% vs. 19.2%) in 2008, in the year 2013, (2.5% vs. 23.6%) and in 2018 (6.5% vs. 25.3%). The regional differentials were statistically significant (p<0.05). For the total sample (Muslim north and south combined), modern contraceptive use ranged from 6% in 2008, to 5% in 2013 and 9% in 2018. Also, the pattern of association between sociodemographic characteristics and modern contraceptive use among the women was quite different for the ten-year (2008-2018) period (Table 3)

Among Muslim women from the north, age, fertility regime, age at first birth, education, household wealth, place of residence, work status, exposure to mass media, autonomy and knowledge of contraceptives were all significantly associated with current use of modern contraceptives. The use of modern contraceptives was higher among women in the younger age group 20-29 years, low fertility regime, age at first birth less than 20 years, women from the rich household, working women as well as those exposed to mass media and those who had knowledge of modern contraceptives. On the other hand, among Muslim women from the South, age, age at first birth, education, household wealth, place of residence, work status, number of living children, exposure to mass media and knowledge of contraceptives were all significantly associated with modern contraceptive use. The use of modern contraceptives was higher among women in the older age group, those whose age at first birth was between 20-29 years, those that had secondary education as well as those from rich household, residing in urban area, working, with between 1-4 living children, exposed to mass media and had knowledge of modern contraceptives (Table 3).

Overall, for the ten-year period, 2008-2018, higher proportion of women who were using modern contraceptives were in the low fertility regime, had age at first birth less than 20 years, had secondary education and were from rich households as well as resident in the urban areas, working, had between 1-4 living children, exposed to mass media, had autonomy, and had knowledge of modern contraceptives (Table 3).

#### Multivariate Analysis Results

Table 4 presents the result of the binary logistic regression. Among Muslim women from the north, factors that significantly predicted modern contraceptive use were education, household wealth, work status, autonomy, and decision on contraceptive use. Increasing level of education and household wealth were associated with higher odds of using modern contraceptives.

Women who were working and had autonomy were more likely to use modern contraceptive relative to those not working and lack autonomy. Muslim women who jointly decide on contraceptive use with their partners were more likely to use modern contraceptives relative to those who individually decide on contraceptive use.

On the other hand, among Muslim women from the South, only age at first birth, autonomy and decision on contraceptive use significantly predicted use of modern contraceptive use. Women whose age at first birth was between the age range 20-29 years and jointly decides contraceptive use with partner demonstrated higher odds of using modern contraceptives relative to those in the younger age group and those who decides on contraceptive use individually. Unlike Muslim women from the North, Muslim women from the South who had autonomy were less likely to use modern contraceptive when compared with those who lack autonomy (Table 4).

#### **DISCUSSION**

The study assessed factors associated with differentials in modern contraceptive use among Muslim women in the North and their Southern counterparts. Muslim women in the North and South differ conspicuously in socio-economic status. These differentials in socio-economic status, no doubt reflected in the differences in modern contraceptive use observed between the two regions. For instance, the proportion of women with no formal education, no autonomy, residence in rural area and belonging to the poor household status were higher in the north relative to their southern counterpart. All these factors have been well documented in previous be studies to significantly associated with modern contraceptive use among women.<sup>5-8</sup> Throughout the ten-year period considered (2008-2018), modern contraceptive use was higher among Muslim

women from the south relative to the North despite the slight decline observed among women in the south in the year 2018. Regardless of the study period, modern contraceptive use was more than five times higher among Muslim women from the South than in the North (23.5% vs. 4.4%).

At the multivariate level, factors explaining modern contraceptive use differ substantially between the regions. Among Muslim women from the North, education, household wealth, work status, autonomy and decision on contraceptive use significantly predicted modern contraceptive use. On the other hand, among Muslim women from the South, age at first birth, autonomy and decision on contraceptive use were the only factors that significantly predicted modern contraceptive use. In addition to the poor socioeconomic status of the Muslim women from the north. a recent study also associated low modern contraceptive use among Muslim women to other factors which included lack of basic sexual and reproductive health knowledge, misconceptions negative and attitude. religious and cultural beliefs and husband opposition to the use of contraceptives.<sup>2</sup> Another associated factor is poor discussion on sexual and reproductive health. 18,19

This study provides important findings with implication for policy and programmes for family planning and contraceptive use in Nigeria, particularly if the country will achieve its modern contraceptive prevalence rate target. Addressing the huge socioeconomic girl's gap, especially education in the north must be pursued holistically. Overall, interventions must seek to correct and address the huge socioeconomic imbalance between the North and South as this will go a long way in bridging substantial the identified The gap. contribution of decision-making power on contraceptive use among Muslim women in the North gives a direction for intervention and indicates that health communication Alabi MA et al – Factors associated with differentials in modern contraceptive use among currently married women in Nigeria: Muslim North versus Muslim South

strategies must put into consideration regional differentials while addressing modern contraceptive use among Muslim women from the North and their Southern counterparts.

#### **CONCLUSION**

Significant differentials in the use of modern contraceptive exist between Muslim women the North and their Southern counterparts. Also, the observed differentials were mainly attributed to the socio-economic inequalities existing in the two regions. Findings from this study provides important information for planners, government and other relevant stakeholders working towards increasing modern contraceptive prevalence rate and eliminating the huge regional differentials in modern contraceptive use and provides direction for intervention.
